Treatment system construction progress continues

Community Update February 3 at 7 p.m.

Northrop Grumman is providing this daily progress report to you on the installation of piping and the construction of the building to support the RW-21 groundwater treatment system. We have completed the installation of all remaining piping to support the system. We would like to thank everyone for their cooperation and patience during the construction process.

Our schedule through January 22 is as follows:

Friday, January 21 and Saturday, January 22: We will complete curb restoration, remove construction equipment and all remaining traffic controls, and conduct street sweeping Friday and Saturday. Central Avenue and the South Sheridan and Hickey Blvd. intersections will reopen mid-day Saturday. Work will be completed by 4:30 p.m. All work is weather dependent.

You may also observe equipment vehicles entering and exiting our staging area off the Hickey Blvd/Sunset Court intersection. We plan to demobilize from the staging area over the course of a few days next week (weather dependent).
