Northrop Grumman is providing this progress report to you on the installation of piping to support the RW-21 groundwater treatment system project—as well as other routine groundwater sampling activities. Our contractors continue to conduct road work on town- and county-owned streets along the piping route. We thank you for your continued support and cooperation.

As of this evening, we have excavated 80 feet of trench along the utility corridor onto Sophia Street and installed the first section of piping within the utility corridor. We also posted our upcoming work notification on parked vehicles at the Bethpage commuter lot off Seaman Avenue to support the start of the mechanical equipment installation for our RW-21 well. I again urge everyone to practice patience and drive with caution while traveling through our work zones. Our priority is the safety of the community and our work crews.

Our schedule through July 28 is as follows:

Tuesday, July 27: Our Sophia Street crew will continue excavating on Sophia Street and installing piping. The piping installed in the utility corridor will be backfilled. Our Stewart Avenue crew will continue assisting the Sophia Street crew. Work will be completed by 4:30 p.m.

Wednesday, July 28: Our Sophia Street crew will continue installing the piping on Sophia Street, while a portion of that crew will begin excavating from the corner of Sophia Street onto the east side of North Herman Avenue approximately 100 feet to the driveway at 130 North Herman Avenue. Our Stewart Avenue crew will also begin removing asphalt, excavating and shoring up the trench starting on S. Pershing for about 50 feet onto Stewart Avenue.

Limited road closures: On Wednesday, July 28, we will install a temporary construction barrier across S. Pershing (east of Totten Street) <u>during work hours</u> to protect our crews while they are working. This road closure will impact driveway access for homeowners at 258 S. Pershing and 369 Stewart Avenue. Our work crews are prepared to provide access should you need it. In addition, the western-most southbound lane of Stewart Ave (from S. Pershing to Central Blvd.) will be closed to vehicle access for 10 days. Our traffic control signs are posted. We'll steel plate the road as needed, and work will be completed by 4:30 p.m.

As a reminder, we ask vehicles on both sides of the streets to temporarily relocate from the excavation and piping installation locations on <u>Tuesday and Wednesday</u>.

Traffic controls and road work signs will remain on Sophia Street running west from the utility corridor to North Herman Avenue; and east side of North Herman Avenue heading north to William Street and then crossing over to the west side of North Herman Avenue to Central Avenue.

Additional work in the community through July

Tomorrow, our contractors will conduct routine groundwater sampling on North Herman Avenue between Sophia Street and Emma Street, and tomorrow through Thursday, July 29 on N4th, N5th and N6th Streets. We ask all vehicles to refrain from parking at least 20 feet from the well sampling locations to allow our technicians to safely access the area.

Tomorrow, we'll begin the installation of mechanical equipment at our RW-21 well located in the townowned commuter parking lot off Seaman Avenue adjacent to St. Martin of Tours from 7:30 a.m. to 4:30 p.m. We anticipate that work will be complete Thursday, July 29 by 4:30 p.m. Please note all work is weather dependent.
