Northrop Grumman is providing this progress report to you on the installation of piping to support the RW-21 groundwater treatment system project. Our contractors continue to conduct road work on townand county-owned streets along the piping route.

We want to thank everyone on Brenner Avenue and William Street for their cooperation and for moving their vehicles during work hours. We again want to thank the St. Martin of Tours Parish leadership for their support. We plan to make repairs on Emma Street within the next several weeks where the paving restoration has settled. Late this afternoon, we removed some of the curbing, sidewalk and grassy area at the corner of Sheridan and Brenner to accommodate the size of the piping we are installing and avoid existing underground utilities. We will steel plate the area until restoration activities occur.

There will be intermittent lane closures as we move across the work zone on Central Avenue (at the N. Herman and Seaman Ave crossing). Drivers who use Central Avenue regularly are advised to use alternative routes to avoid traffic delays at the Seaman Avenue/North Herman Avenue crossing while this work is in progress. Timing to complete this work is weather dependent.

Our schedule through November 12 is as follows:

Thursday, November 11 and Friday, November 12: We will continue trench excavation/shoring, pipe installation, and backfilling on Brenner and Sheridan, as well as trench excavation/shoring across Central Avenue (at Seaman Avenue/N. Herman Ave crossing) with intermittent lane closures on Central Avenue. Work will be completed by 4:30 p.m.

Upcoming Central Avenue work (at Hickey Blvd): Work on the Central Avenue crossing of Hickey Blvd. to Sheridan will follow the completion of the Seaman Avenue/ N. Herman Avenue crossing.

This work will require us to initially close the Central Avenue/Hickey Blvd intersection, followed by the Central Avenue/Sheridan Avenue intersection. There will be intermittent lane closures on Central Avenue as we move across the work zone.

Drivers who use Central Avenue regularly are advised to use alternative routes to avoid traffic delays at the Hickey Blvd/Sheridan Avenue crossing while this work is in progress. We expect that work to take about 30 days. Timing to complete this work is weather dependent.

Safe driving and walking through work zones: Please continue to walk or drive safely around our work zones. Brenner Avenue (between S. Pershing and Sheridan) and Sheridan (between Laurel Place and Brenner Avenue) are closed (except for the residents who reside within those street sections).

Updates to Bethpage School District Walkers/Bus Routes: No additional changes today.

Work vehicles moving in and out of our staging area: You may also observe our equipment vehicles entering and exiting our staging areas off Broadway south of Arthur Avenue and the east side of the Town Municipal Lot B-2 (Seaman Avenue). We will use a portion of the St. Martin of Tours church parking lot (just left of Seaman Avenue) while we install the piping under Central Avenue.
